WHAT IS COVERED BY THIS LIMITED WARRANTY

Master Halco warrants its PostMaster® Galvanized Steel and Powder-coated Texture Black Fence Post product is free from defects in material or workmanship including structural failure for as long as you own your home. "Structural failure" is defined as a permanent bend of more than 5%. This is limited to the original purchaser only on the products noted above. Separate and distinct warranties for hardware and other products are not covered under this warranty.

If the original purchaser is a corporation, partnership, unincorporated association, or a government or public entity, including, but without limitation to, a church or school, the warranty period shall be for a period of twenty (20) years from the date of original purchase. This warranty applies to systems constructed entirely of components manufactured and/or supplied by Master Halco.

WHAT IS NOT COVERED BY THIS LIMITED WARRANTY

This limited warranty does not cover damage resulting from accident, unreasonable use, neglect, alteration, improper service, improper installation, acts of God or any other causes not arising out of defects in materials or workmanship. Additionally, this warranty does not cover costs of installation, removal or reinstallation. Use in harsh industrial, coastal or marine environments is not warranted. Damage from wind loads exceeding 81 mph (Ultimate) for Exposure "B" as determined in accordance with the requirements of the 2015 International Building Code is not covered by this warranty." The natural characteristic of rust formation on the post is not covered by this warranty.
